ORDER

As per paper read (1) above University invited applications for Continuation of Provisional Affiliation for the Academic year 2019-20 from colleges for courses affiliated to the University. The Principals of Pharmacy Colleges mentioned below have submitted application and remitted required fee for Continuation of Provisional Affiliation for the year 2019-20 .

2. The Scrutiny Committee recommended to grant Continuation of affiliation for the year 2019-20 vide read (2) above and the Colleges have submitted renewal permission from AICTE and PCI for the Academic Year 2019-20 .As stipulated in Chapter XXI of First Statutes of the University, the Colleges have constituted College Council.

3. University vide letter read (3) above requested the colleges to furnish Essentiality Certificate from Government of Kerala for further processing of their application for Continuation of Provisional Affiliation since the colleges had not produced the same . The colleges filed Writ Appeal before the Hon'ble High Court of Kerala and the Hon'ble High Court vide order read(4)above directed University to issue formal orders granting Continuation of Affiliation to the colleges.

4. In the circumstances, sanction is accorded to grant Continuation of Provisional Affiliation to the colleges mentioned below for conducting B Pharm course with the annual intake of students specified against each during the academic Year 2019-20 subject to ratification by the Governing Council. **As the last date of admission to B.pharm course is completed on 15/08/2019 appropriate orders have to be**



obtained by the colleges themselves from the concerned authorities to get the same extended before admissions are made during the year 2019-20. The order of the Hon'ble High court read(4) above is complied with as above.

Orders are issued accordingly.

6.The Colleges shall strictly adhere to the general conditions detailed below:-

i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

ii) In the light of the direction of the Supreme Court of India in Writ Petition(c)56/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

iii) Affiliation granted is strictly provisional and only for the academic year 2019-20.The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

iv) The Colleges should remit annual administration fee fixed for UG course for the academic year 2019-20.

v) Admission to the next academic year shall be made only after obtaining prior permission from the University.


